Continuation and Renewal Embryo Cryopreservation Consent Explanation Form

Please read and understand each item on the consent form, check each box below from the dotted line with a *"*□*"* mark, and fill in the required information.

If you have any questions, please ask the embryologist when you come to the clinic.

Cryopreservation Agreement

- There is about 2~3% risk of damaging embryo by thawing. In some cases, this may result in cancellation of the transfer.
- The wife's age must be under 50 years old. Marital status must be continued.
- Although we take measures for natural disaster such as huge earthquake, flood, fire, or other accident, it may be difficult to continue preservation.
- The cryopreservation period is one year. If you wish to renew your cryopreservation after that, please be sure to come to the clinic within 3 months after the expiration date to complete a consent form for renewal. If the renewal is covered by insurance, the renewal can be made from the day after the storage expiration date.
- In principle, we do not accept this consent form by mail. However, if it is difficult to come to the clinic due to unavoidable circumstances, the patient is responsible for sending the form by certified or registered mail. However, please note that the clinic assumes no responsibility for loss of the consent form due to postal accidents.

Agreement on Disposal

- If consent form is not renewal within 3 months after the expiration date, the frozen embryos will be automatically discarded.
- In the event of divorce, if wife is over 50 years of age, or if it is medically determined that treatment is not feasible, the frozen embryos will be discarded.
- We will notify you of the expiration date 40 days prior to the expiration date by e-mail.
 Please circle "YES" if you wish to be notified, and "NO" if you do not wish to be notified.

If you want to contacted the clinic prior to the expiration date, please be sure to register your e-mail address with our clinic's web appointment system (@link). Please do not set your e-mail address to "Unsubscribe (do not need to subscribe)" as you will not be able to receive e-mails before the due date. If one of the couple dies during the storage period, the frozen embryos will be discarded.
